

Today the twenty-sixth of the month of November in the year one thousand eight hundred and thirty-four, at ten o'clock in the morning, appeared before us Master Willem Christiaan Lantman, Mayor of Borne, Province of Overijssel, acting as officer of the Civil State

Johannes Kamerling laborer more than Thirty-six years old according to his baptismal certificate, born in this municipality, adult son of Bernardus Kamerling deceased, in life day laborer, residing in this municipality and died there according to extract from the Registry of deaths, and of the late Harmina Hiddink, in life day laborer, residing in this municipality and deceased in same municipality, according to the deed of notoriety, as well as his grandparents Roelof Kamerling and Berendina Stapel, as well as Jan Hiddink and Mine Knoef, in life all farmers and residing in this municipality and deceased in same municipality, according to the deed of notoriety, and has fulfilled his duty to the National Militia according to certificate,

and Janna Nijhuis Without a special profession, aged over thirty-seven years of age according to her baptismal certificate, born and residing in this municipality, adult daughter of the late Jannes Nijhuis, living in this municipality, deceased as stated in the Extract from the Register of Deaths, and of the late Wilhelmina Oonck, in life Spinner in the municipality of Weerselo and deceased there as stated in the aforementioned certificate of notoriety. As well as Jan Nijhuis and Fenne Lette, as well as Hendrik Oonck and Wilhelmina Wenfink, all the above mentioned of the municipality of Weerselo and deceased there as stated in the aforementioned certificate of notoriety, and furthermore, all the Documents initialed by us have been annexed to this Register and numbered from one to Seven inclusive, including a certificate of insolvency issued by the Mayor of Borne.

After which we were requested to proceed to the confirmation of their intended marriage, of which announcements were made, before the main door of the town hall here, on Sunday the Twenty-sixth of

October, and Sunday the second of the month of November one thousand eight hundred and thirty-four, at eleven o'clock in the morning, according to the Registry of Marriage Announcements of this municipality.

No hindrance or controversy against the prescribed Marriage being served upon us, Thus it is, that we, in right of their request, after having read to them all the aforementioned Documents, as well as the Sixth Chapter of the Civil Marriages, have asked them, whether they in each other thus for man and wife assume, each separately having given their consent to this, we declare in the name of the law, that Johannes Kamerling and Joanna Nijhuis are united by marriage.

Of which we have drawn up this act, in the presence of Jannes Mulder weaver aged thirty-one years Ten Wildiek, reed maker, aged thirty-two, Gradus Leuverink, weaver, aged forty-seven, Antonie, weaver, aged fifty, all residing in Borne and chosen as witnesses by the contractors, each of whom declares that the contractors are not related and not intermarried, and this deed was signed by us, together with the first-mentioned witnesses, after it had been read out, and the contractors and the last-mentioned witness declared, upon our request to sign, that they were unable to do so, being inexperienced in writing.
